(1) Have you passed THREE FULL YEARS OF FINANCIAL ACCOUNTING?

(2) Have you passed TWO FULL YEARS OF AUDITING? Note: <u>Internal Auditing is not accepted</u>			

Note: Students with a BCom Accounting degree from the following Institutions: Rhodes University, KZN University, Nelson Mandela Metropolitan University (NMMU), University of Cape Town and University of the Witwatersrand only need a one year Auditing and one year Financial Management Course on third year level.
